

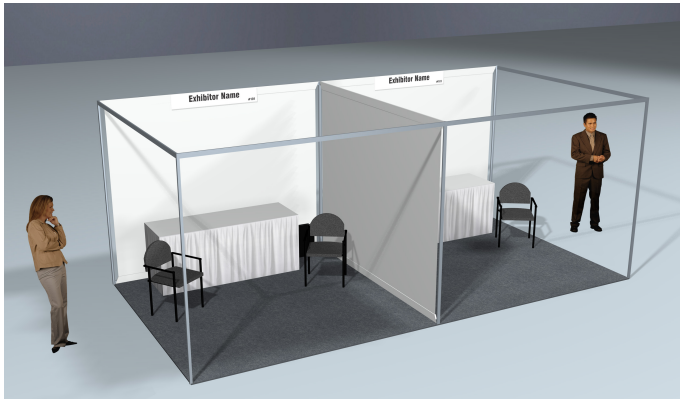
## Booth Package

### Dismantle & Move Out Information

### Post Show Paperwork & Labels
